**RECOMMENDATION:** To ratify the award for the Student Center efficiency project for the base bid amount of \$318,400.

**RATIONALE:** In response to the advertisement for competitive bids, we received four submissions for the Student Center efficiency project. Samron Midwest Contracting is the recommended bidder based on competitive pricing and meeting all bid specifications as provided below. The low bidder—Bee Liner Lean Services—requested to withdraw their bid following the bid opening. The recommendation letter is attached.

We have reviewed the bids received for the above project. I have discussed the bid with the apparent low bidder Mourad Chekhar and received an email from Robert Marin of Bee Liner Lean Services. The bid was significantly lower than the other bids received. I received an email from Robert stating that since there is a Project Labor Agreement on the project, they would not be able to absorb the additional cost to become a signatory to the local unions and have requested to be released from their bid.

The second lowest bidder was Samron Midwest Contracting. Upon withdrawl of the bid from Bee Liner Lean Services, Samron would be the low bidder. I have spoken with Bryce Layne with Samron and he stated they are comfortable with their bid as submitted. Samron has worked on several projects in the area including other local community colleges, as well as a recent projects with our firm.

I know of no reason for the College not to accept the lowest responsible bidder, Samron Midwest Contracting.

- 15. Recommend and maintain policies and procedures for the facility.
- 16. Maintain supplies, equipment and materials in support of relevant programs.
- 17. Maintain all necessary license and certifications required to properly perform job duties as assigned.
